Judging Begins 1:00 pm on Friday and 8:30 AM Saturday & Sunday. These trials will be held in two (2) 90'x 100' rings inside on bark and dirt. Both rings may be running at the same time.

OBSTACLES

Obstacles shall meet the specifications for obstacles in the current edition of AKC Regulations for Agility Trials. All jumps will be displaceable. There will be no obstacle familiarization.

EQUIPMENT

The equipment for this event is provided by K-9 Sports LLC. Information on equipment rental can be obtained by contacting Lori@k-9sports.com or calling (503) 632-2227.

AWARDS

Ribbons will be awarded to first through fourth place in each height division in each class. A qualifying score is required for all awards. All awards must be claimed at the show. First Place: Blue Ribbon ➤ Second Place: Red Ribbon ➤ Third Place: Yellow Ribbon ➤ Fourth Place: White Ribbon ➤ Qualifying Score: Dark Green Ribbon. Please let us know if you are statistically capable of MACH or PAX so that we may have a ribbon ready for you.

Saturday March 24, 2012 Papillon Club of America (PCA) will have a supported entry giving a Breed Medallion for Highest Scoring Papillon.

Sunday March 25, 2012 Papillon Association of Puget Sound (PAPS) will have a supported entry giving a Visa Gift Card (\$40.00) for Highest Scoring Papillon.

MOVE-UPS

Move-ups after entries close must be submitted to the Trial Secretary in writing (email is acceptable) by 6 pm PST on March 19, 2012. Moves-ups will be accepted each day of the trial for the following trial day and must be submitted in writing no later than 30 minutes after the trial ends each day.

WALK-THROUGHS AND WARM-UPS

Handlers in all classes will be permitted to walk the course without a dog prior to the start of a class. At the judge's discretion, if the size of the entry for any class might inhibit a safe and fair walk-through by handlers, height divisions may be used to divide the walk-through into groups, e.g. walk-through for the 8", 12", and 16" division handlers followed by runs for those height divisions; then walk-through and subsequent runs for the 20"/24"/26" divisions. A warm-up area, consisting of a regulation agility jump, will be provided.

DOGS ELIGIBLE TO ENTER

This Trial is open to all dogs 15 months and over that are registered with the American Kennel Club or are registrable breeds that have obtained ILP/PAL (purebred alternative listing) numbers from AKC, except bitches in season, aggressive dogs, blind or deaf dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

CLASSES OFFERED

A complete set of rules for all classes is available from the American Kennel Club (8051 Arco Corporate Dr Raleigh, NC 27617-3390) or from the AKC web site (www.akc.org). It is the exhibitor's responsibility to enter their dog in the correct class. The Trial Secretary cannot make any changes (except move-ups as noted) after the closing date of the trial. **Be sure to check your entry form carefully and make certain you have entered the correct class(s).**

HEIGHT DIVISIONS

The following jump height divisions shall be used in all trial classes:
8 inches for dogs 11 inches & under at the withers or 4" Preferred
12 inches for dogs 14 inches & under at the withers or 8" Preferred
16 inches for dogs 18 inches & under at the withers or 12" Preferred
20 inches for dogs 22 inches & under at the withers or 16" Preferred
24 inches for dogs over 22 inches at the withers or 20" Preferred
26 inches at the owner's request

Please include a copy of your Jump Height Card with your entry. All Dogs without height cards must be measured by the judge, except 24" and 26" unless a VMO or REP is present.

IMPORTANT INFORMATION FOR EXHIBITORS

- ◆ **All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.** AKC does not permit pinch/prong collars, electrical or special training collars anywhere on the trial grounds.

- ◆ **The safety of dogs is of primary concern.** By entering the Trial, exhibitors acknowledge that they are familiar with the rules and regulations of the sport, and that their dogs are familiar with and able to perform all obstacles safely.
- ◆ Confirmation of entry and schedule of judging time will be sent via email if one is provided to the address on the official AKC entry form after the closing date. **If an exhibitor has not received from the trial secretary a copy of the schedule and confirmation of entry at least seven days prior to the show, contact Theresa Calter** (Theresa@K9EventsNW.com or (206) 282-6503). Returned checks do not constitute a valid entry.
- ◆ Conditional, unsigned, incomplete, illegible, telephone or emailed entries cannot be accepted. Entries not on official AKC forms or photocopies of **AKC forms without the signed agreement and rules on the reverse side of the official AKC entry form are not acceptable.**
- ◆ Entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date, or in the event a dog is absent, disqualified, sick, lame, excused by the Veterinarian or Judge, or barred from competition by the Trial Committee or the AKC. No entry fee will be refunded if the trial cannot open or be completed for reason of riots, civil disturbances, fire, act of God, public emergency, act of public enemy, or any other cause beyond the control of the organizing committee.
- ◆ The Boston Terrier Club of Western Washington, Argus Ranch, K9 Sports and K9 Events NW assumes no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or spectators, or to any of their dogs or property, and further assumes no responsibility for injury to any child not under the control of his or her parents or guardians.
- ◆ It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the Trial site. In such cases, no refund of any fees paid will be made.

It is a requirement of the AKC, the club and the facility that dogs be on leash at all times except in designated off-leash areas. Owners must clean up after their dogs or they may be barred from further trials.

CONFIRMATION PROTOCOL

If an email address is provided, an email confirmation will be sent at the time of processing, 48 hours after the trial closes and for every move-up or correction. You need to have your filter set to allow email with attachments from theresacalter@k9eventsnw.com . Paper confirmations will only be sent when an email is not provided. To help overcome the time it takes for USPS delivery, please check after closing at www.K9EventsNW.com under Upcoming Trials for details about this trial's judging order, entry statistics, worker schedule and general information.

You may make any changes necessary to your entry before closing but after closing, the secretary may only process move-ups (not moving down to a lower level nor switches between regular and preferred tracks) and corrections to dog/owner/handler information.

OWNERS/HANDLERS ARE RESPONSIBLE for checking each dog's entry and information each time it is sent and contacting the trial secretary immediately if a correction/change needs to be made. All changes and corrections must be submitted in writing and email is preferable (theresacalter@k9eventsnw.com).

Always bring a paper copy of your confirmation letter to the trial along with your dog's AKC jump height card otherwise the database is the final authority for the day's information.

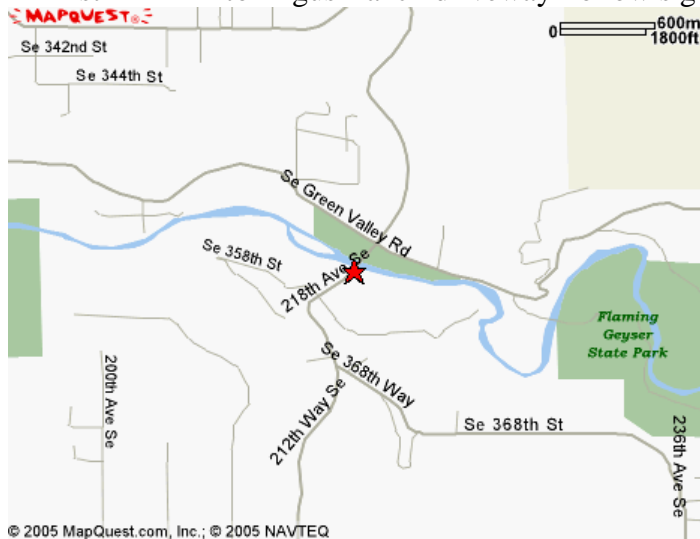

AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. INSTRUCTIONS

Handlers may opt to enter in a higher height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
